

## Waiver of Liability For the Chicago Cruisers

I understand that each member of the Chicago Cruisers is responsible for his/her own actions while participating in any Chicago Cruisers event, and that each rider is personally responsible for abiding by all traffic safety laws. I will not consume any illegal substances during any ride or event.

I agree that Chicago Cruisers is not the guarantor of any rider's safety (either as operator or passenger) during any event or ride.

I understand that some degree of danger or possibility of personal injury exists with the operation of any motor vehicle, and I agree to participate only in rides or events for which I have the ability to safely participate, and for which I have the equipment necessary for my safe involvement.

If a member of the Chicago Cruisers invited me to join the Chicago Cruisers, I understand and agree that such invitation was extended to me based solely on my interest in riding a motorcycle and is not an assessment of my abilities or equipment for safe participation in Chicago Cruiser events and rides.

I understand that the routes planned for all rides will be on public roads, unless so stipulated, and neither the Chicago Cruisers nor the individuals who planned the route(s) is a guarantor of the roads' conditions or the actions of other drivers on those roads.

If I have any doubts or concerns about my abilities or equipment, the condition of the planned route, or about having adequate insurance coverage to compensate me or any other person for any injury or loss that may occur, I will voluntarily withdraw from any ride or event before starting or at the time that such doubt or concerns arise.

My participation in Chicago Cruisers sanctioned events is voluntary and done for my own pleasure. There will be no entry fees, prizes or concessions for which I will be expected to contribute, other than the voluntary donations to support the Chicago Cruisers.

All Chicago Cruiser events and rides are offered solely for the purpose of associating with other chapter members for pleasure in their mutual interest, motorcycles, and in no way benefits the individual who invited my participation, monetarily or otherwise.

My signature below signals that I have read and understand this Waiver, the terms of which I fully agree, and that I accept full responsibility for my own actions and liabilities incurred during any Chicago Cruisers event or ride.
